You may arrive no earlier than 9:00 a.m. Registration for Day of Show entries will be at 9:30 a.m. Day of Show Entries permitted only if desired class is not full. You are responsible to bring all necessary items required for your dog's entry in classes/competition.

The crating area is upstairs, at Denver Dog Sports and signage or a steward will direct you to that area, after check-in.

It is suggested that you bring the following items on the day of Trial:

- Crate
- Mat for under your crate to protect facility flooring
- Required leash & collar
- Chair/pad
- Blanket to cover crate (helps to calm the dogs during trial)
- Treats

A buffet style lunch will be provided for competitors, workers and officials. Donations will be accepted to offset the cost of the food and drink provided.

## Directions to Denver Dog Sports

Coming from the north or south, on I -25, take I-70 going east:

From I-70 East: Take the Dahlia/Holly/Monaco exit and stay on the frontage road, in the right lane, along Stapleton St. Continue through the first stop light, which is Dahlia, past the Safeway Distribution center on your right. Turn right on Forest St. and come up 1 block. Denver Dog Sports will be on your left. 4300 Forest St., Denver CO. You may park in front of the building on the west side, or behind the building on the east side, in a larger parking lot, near the outdoor dog-walking area.
